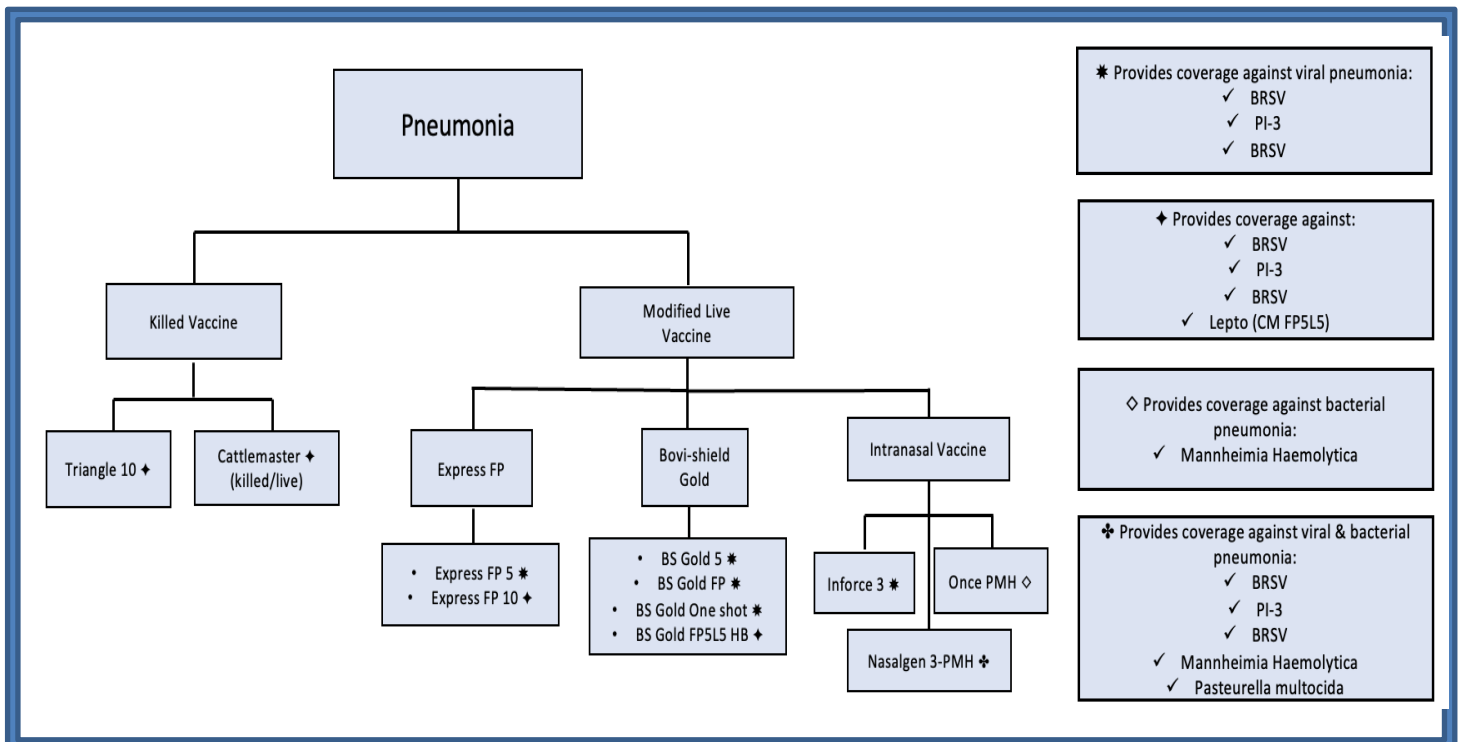

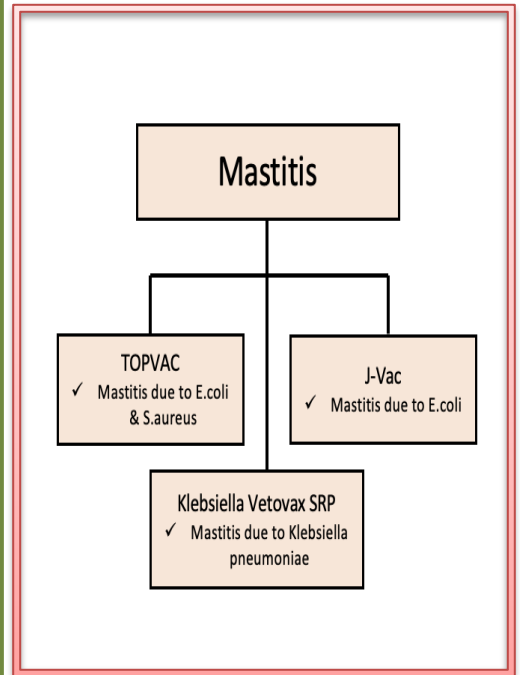
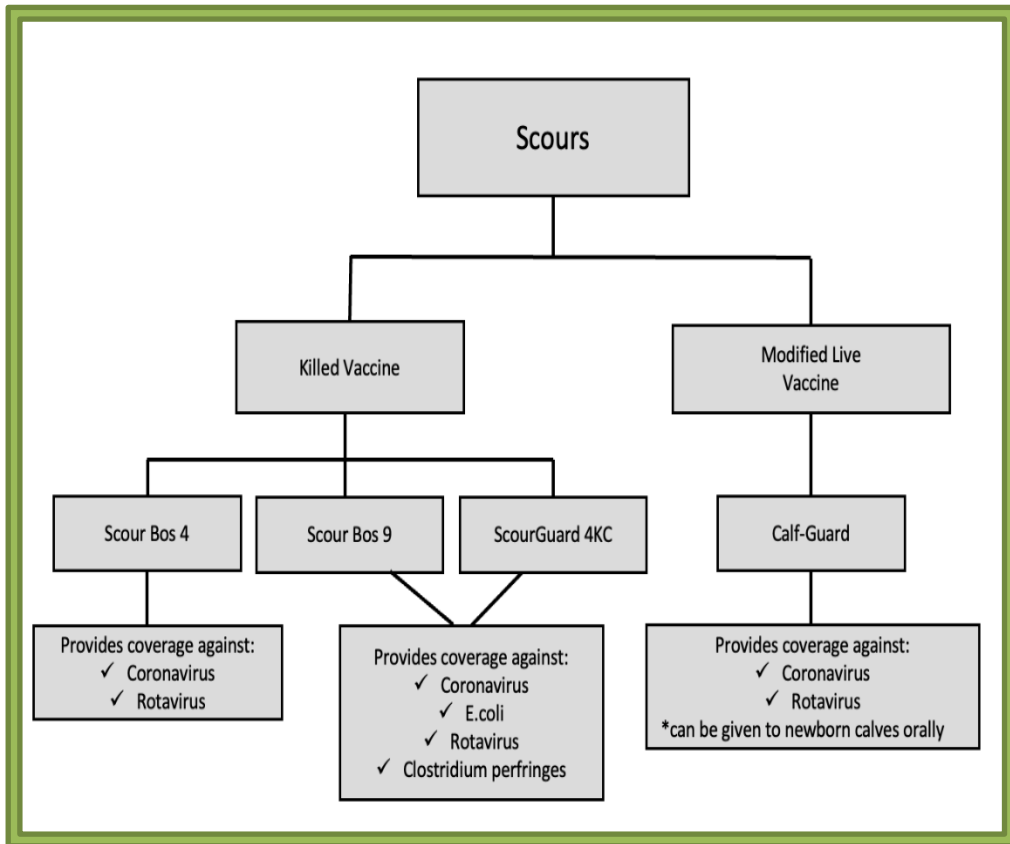

VACCINATION- Part 2

Part 2 of the 2-part vaccination series will focus on the specific vaccines offered in clinic and their use. See the charts below which highlight vaccines available for pneumonia, scours and mastitis.

CQM Updates from Glenna:

SOP's

- We continue to add and update the Biosecurity and Down Cow SOP's

MMS

- In February DFO changed their online system that we used to view your water test results and pick up information. Without access to this we cannot print your water test results that are needed for full validations and self evaluations.
- We have been requesting that producers call MMS (1-877-817-7646) to grant linwoodvet@linwoodvet.ca access so that we can print your water test results.

As of September 1, 2021 you must report animal movements to **DairyTrace**, and the **Environmental** portion came into effect.

- DairyTrace
 - You can report animal movements online, using the app or by phone (phone number on enclosed poster)
 - Refer to the enclosed Traceability poster for the deadlines for reporting each type of animal movement
 - At each full validation you must show that you have been maintaining on farm records (ex. DHI log book, computer, etc.) for animal movements
 - You must also print out the DairyTrace ProAction report that shows you have reported each animal movement to DairyTrace
 - Can be found online on your account or you can call DairyTrace (1-866-558-7223) and they will mail out a copy at no cost to you.

○ Environmental

- Must do an environmental questionnaire at every full validation and have it submitted online
 - If the questionnaire is not submitted online you will be given a major
 - The questionnaire is **NOT** done online when you do your environmental farm plan
 - Once submitted online you will receive a scorecard based on your answers. This is for your reference and lets you know if you are doing a good job. Please keep this for your records and if necessary use it to make changes.

- Must have an Environmental Farm Plan (EFP)
 - Must be from within the last 10 years and it is recommended to update your EFP every 5 years
 - 1 day renewal either in person or online
 - 2 day in person course for anyone that has never had an EFP or it is more than 10 years old
 - Please call Ontario Soil and Crop 519-826-4214 to get your name on the waitlist for the next course in your area
 - Under current Ontario government rules, to attend an EFP course, you need to show that you have had two Covid 19 vaccines, or show proof of a valid medical exemption, and present valid ID.

If you are not vaccinated for Covid 19, Ontario Soil and Crop still recommends *getting your name on the waiting list for the next EFP in your area*. This way if rules change you might be able to attend the course, and DFO sees that you are trying to get into a course.
